

LEGISLATIVE MONITORING TOOL

The National Public Records Research Association (NPRRA) has acquired a subscription on behalf of our members to a legislative monitoring tool called BillTrack50 (www.billtrack50.com). This invaluable tool is offered at no cost nor obligation to NPRRA member companies. Please reference the FAQs below for more information on how to take advantage of this helpful NPRRA member benefit.

Frequently Asked Questions:

What is BillTrack50 and why would I wish to have access to it?

Answer: BillTrack50 powered by LegiNation, Inc. is a legislative monitoring tool that allows users to query, flag, and monitor legislation. Users can create custom searches, flag relevant legislation from query results, view bill text, and monitor the progress of flagged bills as they move through the legislative process.

What are some examples of legislation I may wish to track?

Answer: There are a variety of legislative topics that may be of interest to NPRRA members such as: bills which may affect corporate filing fee changes, bills which modify corporation codes, legislation which affects financing transactions.

How can I gain access to BillTrack50?

Answer: Email info@nprra.org or go to www.nprra.org to locate a NPRRA GAC Committee Co-Chair. You will need to provide the following information for up to two people at your company: First and last name, email address and whether you'd like administrative access, view only access or both. Administrative access will allow each company to set up their own bill sheets. View only access will allow you to view NPRRA bill sheets only.

What training resources are available to NPRRA Members for BillTrack50?

Answer: BillTrack50 and the NPRRA GAC have partnered to bring you webinars aimed at helping our members learn how to craft queries (bill sheets) in BillTrack50, and manage query results. Watch for email updates with information on how to join an upcoming webinar.

Can other users see or modify my bill sheet queries/results?

Answer: No. Each user will be set up as an Admin for their company's bill sheets. They will be able to take any action within BillTrack50 related to up to two bill sheets. However, they will neither be able to see nor modify any other company's bill sheets. Having said that, users will be able to add specific bills from their bill sheets to the general NPRRA bill sheets when they see legislation that they may wish to call to the attention of other NPRRA members.

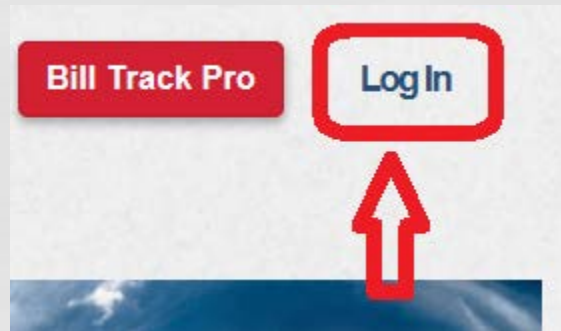

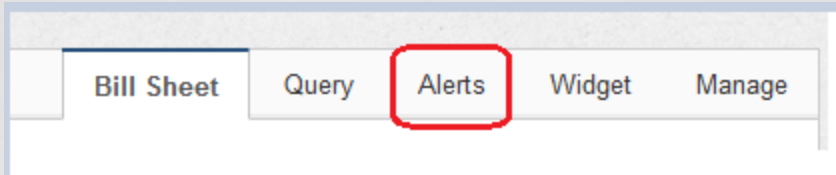
